## SECL KE SUSHRUT A CSR Initiative of SECL for NEET coaching to underprivileged

### Scheme Details

#### A. For Selection of Students :

1. The selection of students for the coaching will be through a competitive offline exam based on the same pattern as NEET'2023.
2. The last date for online registration is September 6<sup>th</sup>, 2023.
3. The selection test will be held offline in all SECL Areas on September 10<sup>th</sup> 2023, Candidates can opt for the preferred centre while filling up of form.
4. Admit cards will be issued through email or can be downloaded from the portal from 3<sup>rd</sup> September'2023 onwards

6. The selection test will be conducted by Premier Academy - a Bilaspur-based private coaching institute.
7. Medium of the selection test will be Bi-lingual i.e Hindi & English.
8. Eligibility Criteria proposed for Selection of Students is as follows:
  - i. Students who have passed 12<sup>th</sup> Class exam and residents of Project Affected Villages & Nearby locations (Other than SECL employees) located within 25 KM radius of SECL Establishment  
or  
Students should have passed 12<sup>th</sup> Class exam from the School, which is located within 25 KM radius of SECL Establishment in the Operating Districts of Korba, Raigarh, Koriya, Surguja, Surajpur, Balrampur & Manendragarh-Chirmiri-Bharatpur Districts of Chhattisgarh & Umaria, Annuppur & Shahdol Districts of Madhya Pradesh only. The student must submit the following documents for verification of eligibility under the said project:
    1. Aadhar Card/Voter Id Card/Driving License/Pan Card or Ration Card with Photo for the person whose photo is affixed
    2. 12<sup>th</sup> Marksheet mentioning the name of school, which falls within 25 KM of SECL Establishment or स्थानीय निवासी प्रमाण पत्र issued by the State Govt. Authority mentioning the name of village which falls within 25 KM of SECL Establishment
    3. Domicile certificate of Chhattisgarh or Madhya Pradesh  
Competent Authority of the Concerned Areas of SECL (as decided by GM-CSR) shall

certify that the school from where the Selected Student has passed 12th Class, or स्थानीय निवासी प्रमाण पत्र issued by the State Govt. Authority mentioning the name of village, which falls within 25 KM of SECL Establishment or not within the stipulated timeline. SECL decision in this regard is final.

- ii. Wards must obtain minimum 60 % marks in Std 12th Board examination (CBSE/CG Board/MP Board/ICSE) and eligible for appearing in NEET as per the eligibility criteria of NEET-2023
- iii. Students must be Domicile of Chhattisgarh or Madhya Pradesh.
- iv. Students must clear the cutoff of the test to be conducted for entrance.
  - v. The students, who have passed Class 12<sup>th</sup> along with minimum 60 % marks in Std 12th Board examination will be eligible for the test. Students clearing the test but not obtaining 60 % marks in the 12th Board will not be considered for the coaching.
- vi. The Gross Income of the Parents/Guardians should not be more than ₹ 8,00,000/- (Rupees Eight lakhs per Annum). Income Certificate from appropriate Government authority/Income Tax Return of Parents or Ward's Name registered in Below Poverty Line (BPL) Card/ Antyodaya Anna Yojana Card will have to be submitted before admission to coaching programme. Students unable to produce the Proof of Income at the time of admission will not be eligible for admission to the coaching.
- vii. The candidates should be free from any chronic disease and a certificate to this effect from a Registered Medical Practitioner will have to be submitted at the time of admission.
- viii. Reservation for SC-14%, ST-23% & OBC-13% will be maintained in Selection Criteria of No. of Seats. The reservations are in line with letter No. 55011/4/2014-PRIW II GOI, MOC dated 05.02.2016 issued by Under Secretary, Ministry of Coal. If the No. of Seats remain vacant in any of the category the same shall be transferred to Unreserved category, the decision of GM-CSR shall be final in this regard.
- ix. The wards & dependent of SECL Employees are not eligible under this scheme.
  - x. The Selection list will be prepared as per the marks obtained and as per the reservations. In case of students obtaining same marks the seniority will be decided by the following:
    - a. The age in descending order, the older student will be senior to the junior
    - b. If the age is also same, then the percentage of Marks obtained in 12th Class will be the selection criteria.

#### **B. For Coaching of Selected Students (Including Boarding and Lodging):**

1. On behalf of SECL, Premier Academy - a Bilaspur-based private coaching institute shall provide residential coaching for NEET Examination to 35 Nos of Selected Students who has passed 12th. The coaching will be provided at Bilaspur.
2. Extra Classes if required for timely completion of course for NEET2024 shall be carried out by the Coaching Institute.
3. Food will have to be provided to all the students as per standardized menu in line with the menu of Sainik School Ambikapur.

4. The necessary items like Bed, Mattress, Pillow, 4 Nos of Bedsheets, 2 Nos of Pillow Cover, One No. of Blanket, Water Jug, cupboard with Lock & Key, Table Lamp, Study Table & Chair will be provided to each student by the Coaching Institute
5. The selected institute shall conduct periodic tests to the students sponsored by SECL and communicate the marks & ranks obtained by the students in those tests to SECL.
6. The coaching institute shall ensure for enrolment and appearance of students in the periodic/mock tests to be conducted at All India Level and shall communicate the marks & ranks obtained by the students. Institute will also provide a comparative performance report of each student of the Batch Sponsored by SECL with their Ranks among their other batches at Bilaspur and at All India Level.
7. Adequate Safety & Security of the students will be the responsibility of the Coaching Institute. SECL shall not be responsible for any violation or non-compliance of the laws/ rules by inmates/students & SECL shall not be responsible for any compensation for injury and other unwanted incidents from any causes whatsoever.
8. **TIMELINE:** The project shall be completed by end of NEET Exam in 2024 or 11 months from the start of coaching which so ever is earlier and it has to be completed within the timeline fixed by SECL.
